DID YOU KNOW

Sigma Chi Foundation has received more total annual support and provided more program services (scholarships & educational programs) than any other Greek-letter foundation on average over the previous 10 years.

Sigma Chi's leaders from both the Fraternity Executive Committee and Foundation Board of Governors met in January to continue work on a ten year plan that will proactively develop character based leaders.

Key themes of the plan are learning continuums for all Sigma Chis from pledging through the chapter eternal and a reconnection vehicle to our ritual.

When final, the plan will prioritize numerous programs and services for undergrads and alumni that will help the Sigma Chi experience truly be a lifelong one.

During the annual grant review session, leaders discussed results from the official launch of Sigma Chi U and its Preparation for Brotherhood (P4B) program as well as status updates of leadership programs the Foundation funds and the Fraternity develops and executes.

Future planning includes the expansion of Sigma Chi's education and leadership programming to every undergraduate brother, every year through Sigma Chi U, leveraging alumni and volunteers, and expanding professional support to chapters and volunteers.

SIGMA CHI U

After a successful 2015-16 pilot, Sigma Chi officially launched the Preparation for Brotherhood (P4B) program, our new pledge education module, to all chapters in Fall 2016 impacting nearly

4,000 undergraduate pledges as part of Sigma Chi U.

Over 93 percent of participants in the program rated the knowledge gained from the P4B program as excellent or good, while 93 percent of pledges completed the program en route to membership.

Sigma Chi also created and launched supplementary curricula for the Balfour Leadership Training Workshop, including facilitation training guidance and the Strategic Visioning 101 program for all undergraduate attendees.

Modules for Sigma Chi Lifeline (suicide prevention and mental health awareness), post-initiation and chapter advisor training are slated to debut in 2017 with additional program slated to roll out over the next three years.

BALFOUR LTW

In 2016, 1,376 undergraduate brothers in various officer roles representing 245 chapters and colonies participated in the annual leadership training workshop at Bowling Green State University in Ohio.

Chapters were led through a strategic planning curriculum consisting of eLearning activities delivered via Sigma Chi U and five sessions with a trained facilitator.

In addition, chapter officers received specific training that emphasized the values-based decision making model, especially as it related to critical issues such as alcohol and drug abuse, hazing

and sexual misconduct.

A facilitator training session also took place for the Mission 365 program.

HORIZONS

The Huntsman Horizons Leadership Summit reached a new pinnacle in 2016 with the launch of a fifth session at Snowbird, Utah sponsored by Significant Sig Bob McNair, **SOUTH CAROLINA 1958**.

Eight new facilitators were trained in September 2016, and past participants were encouraged, in coordination with the Foundation, to support the program through the "Pay It Back, Pay It Forward" campaign.

ADDITIONAL HIGHLIGHTS

- Several chapters took part in chapter-specific workshops last fall (Crossroads, Accountability and Sexual Misconduct Prevention), while 172 chapters submitted a strategic plan and 138 scheduled a strategic visioning workshop for the current academic year.
- Work has begun on new mental health awareness curricula to supplement the existing Sigma Chi Lifeline program, which serves all Sigma Chis.
- Sigma Chi delivered a series of Mission 365 retreats in 2016 with additional chapter events scheduled or requested for the current year, helping undergraduate members learn a recruitment process and techniques based on the Jordan Standard.

Giving back in a new way

Former International Sweetheart establishes first of its kind award for sweethearts at chapter level

Long after her two-year journey as Sigma Chi's International Sweetheart, Jacque Lehn became a doctor, a nationally-renowned innovator in her field of gerontology, a CEO and Founder of three companies in her field, a mother and wife to a Sigma Chi.

Through it all, she maintained her love of the Fraternity and the role she served proudly at the International level as well as at her local chapter.

Today, Dr. Jacque DuPont Carlson and her husband Marc, **PURDUE 1982**, are making an impact on the beloved sweetheart role with a first of its kind award at the Greek-letter fraternity level.

This summer, all current and former chapter sweethearts still enrolled in their undergraduate studies will be able to apply for the Sigma Chi Undergraduate Chapter Sweetheart Scholarship — to be awarded for the first time this fall.

"I think Sigma Chi does a fabulous job honoring their sweethearts in so many ways with the Sweetheart Ball, the beautiful sweetheart pin and the many local chapter traditions," said Carlson. "However, I think women today have evolved and really deserve academic awards."

Inspired by Carlson's own journey, the award will go to a young woman with a solid academic record and exceptional involvement and leadership as sweetheart for a Sigma Chi undergraduate chapter.

"What a better award to give back to them for their countless volunteer hours than a scholarship? I remember helping my chapter in so many ways with rush, with charity events and that needs to be honored," Carlson said.

An Alpha Delta Pi, Carlson's Sigma Chi journey began as a sweetheart at the chapter level at San Diego

State. She was selected International Sweetheart for the 1989-1991 term following a nationwide search, and she immediately took on an active role as one of the first sweethearts to extensively travel during her graduate studies at University of Southern California.

"I really enjoyed going to chapters," Carlson said. "I was able to go to over 50 chapters and it was so special to see how unique — although Sigma Chi is alike in greatness, it is also alike in uniqueness. We did a nationwide toy drive that was really fun."

She would go on to greater success as the CEO and Founder of DuPont Residential and Memory Care, Inc., Assured In Home Care, Inc. and Vista Gardens, LLC., receiving national recognition in the 1990s for implementing an innovative video-camera monitoring system to protect older adults from abuse within care facilities.

She has received numerous accolades and awards

for her hours of dedication to resident families, eldercare organizations and community work, and sits on the Boards of Directors of several organizations. In 2005, during a visit to Cincinnati and Sigma Chi's 150th anniversary celebration, the fraternity impacted her in a different way as she met her husband Marc. Together, they have seven kids and presently reside in California.

Carlson is one of many sweethearts to find success following their roles within Sigma Chi. She hopes this award inspires former international sweethearts and chapter sweethearts to also give back and honor the young women to serve their chapters today.

"I want to encourage all of the past international sweethearts to give to this," she said. "It's our way, as sweethearts, of saying 'thank you' to the effort that is nationwide at every chapter. We're supposed to be the role model and the example as International Sweetheart, but the hands on, giving back is at the local level."

The new award will join the already existing International Sweeheart scholarship, presented annually by the Sigma Chi Foundation.

Current International Sweetheart Kelsey Maggard believes the new honor will provide more awareness of Sigma Chi at the international level for chapter sweethearts.

"Right now there isn't a lot for the chapter sweetheart at the international level, so I think this is going to be a good way to give them exposure to the international fraternity," said Maggard. "So many of the women at the chapter sweetheart level fit the criteria of an International Sweetheart. I think this is going to be a good way to honor those awesome women."

Giving back inherits new meaning through Sigma Chi Lifeline program

Among the many important asks of a Sigma Chi within our ritual, the responsibility within each brother to lend strong arms to another in a time of need is perhaps one of the most meaningful.

Giving back to a brother, our chapter or our Fraternity at large is within our Sigma Chi DNA. It is something our seven Founders

Each year, thousands of Sigma Chi alumni and undergraduates volunteer thousands of hours on behalf of Sigma Chi in their communities and within their own chapters.

Thousands more contribute financially through the Sigma Chi Foundation, helping provide academic scholarships and values-based leadership programming within a generation of brothers where those things mean more than ever before.

Sigma Chi itself, over the previous two decades, have taken extra steps to highlight issues of need within young adults such as drug and alcohol abuse, the dangers of hazing and prevention of sexual misconduct.

In 2014, however, the untimely loss of Keller Zibilich, **LOUISIANA STATE 2015**, highlighted a recurring issue in today's collegiate scene: A rise of mental health issues, suicide and depression.

In many cases these issues are unnoticed by friends, family and loved ones, especially within young adults.

With the support of friends, family and fellow Sigs,

Keller's parents, Michael and Gayle Zibilich, were instrumental in the creation of the Sigma Chi Lifeline program and Sigma Chi's relationship with the JED Foundation to provide all Sig undergraduates and alumni with the tools needed during a time of distress — a true awareness of displaying strong arms to comfort and protect a brother or loved one.

This year, Sigma Chi is partnering with the JED Foundation to expand upon Lifeline with the development of a new mental health and suicide awareness to reach all undergrads through Sigma Chi U in Fall 2017.

In support of this project and a scholarship in their son's name, the Zibilich family will host their annual Keller Zibilich Golf Tournament on Tuesday, May 9 at the Fairways of Canton in Atlanta, GA.

Also, the Sigma Chi Foundation will once again honor Keller and other Sigs who have entered Chapter Eternal far too soon due to suicide, as well as those enveloped by mental health issues with our second Mental Health Awareness Week.

Both events will raise funds towards highlighting the new programming and lending strong arms to those who may need our support now more than ever before.

Bequests may be specific, such as a dollar amount in cash, identified securities, or listed articles of tangible personal property. Bequests can also be general, such as a percentage of the residue of the estate. Once you have prepared your will, we ask that you provide a copy to the foundation for our records. Please know that we treat this as strictly confidential information.

INSURE SIGMA CHI'S FUTURE

Gifts of life insurance are a way to leverage your support of the foundation to support the values-based leadership programs of Sigma Chi into the future. There are several options to provide this type of gift. If you choose to name the foundation as a beneficiary,

you would continue to make premium payments to your insurance company.

You can also choose to make the foundation the owner of the policy and make tax-deductible gifts to the foundation to pay the premiums. Upon payment of the policy, the funds would be used for your designated purpose.

GIFTS THAT PAY YOU BACK

With a Charitable Gift Annuity (CGA), you provide the foundation with a tax-deductible gift of cash, appreciated securities, or other acceptable assets. In return, you receive a fixed income for the remainder of your life. When annuity payments end, the remaining principal of your gift becomes available to the foundation for your designated purpose, whether it's leadership programming, academic scholarships, museum and historical initiatives or operations.

SPECIAL RECOGNITION

The Sigma Chi Foundation recognizes those who create planned gifts with membership in the James Parks Caldwell Society. Caldwell Society members are recognized within the Sigma Chi foundation's Annual Report, receives a distinctive lapel pin and Sigma Chi foundation publications.

Bell reaches 75 chapters

On the heels of the program's ninth year, the Sigma Chi Foundation's Thomas Cowan Bell Chapter Challenge has reached a new milestone as it makes an impact across participating undergraduate chapters.

Thanks to the engagement of alumni and the Foundation's development team across the United States, 75 of Sigma Chi's 240 chapters attained Bell benefits for the 2017-18 fiscal year.

"The long-term goal of the Bell Chapter Challenge program has been to provide top of the industry values-based leadership programming and scholarship support to our undergraduate brothers," said Foundation President and CEO Ashley Woods, **EAST TENNESSEE 2000**. "The impact it has on our local chapters and the satisfaction of our alumni donors, has proven to me that it has the tools necessary to make a big difference."

Participating chapters at the Blue level (\$10,000 annually) receive additional registration slots at Balfour Leadership Training Workshop, a designated spot for a qualified applicant at Huntsman Horizons Leadership Summit in Snowbird, Utah, two \$1,000

academic scholarships for active brothers, a comprehensive Crossroads drug and alcohol awareness retreat and a travel stipend for the trip to BLTW.

"Sigma Chi is the best organization that I know for the development of character and leadership in deserving young men," said Bell donor Douglas Lundy, MD, **NORTH GEORGIA 1986.** "The programs and content produced by Sigma Chi across the country is the stuff Fortune 500 companies would love to replicate. I support the Bell Chapter Challenge to provide opportunities for deserving Sigma Chi undergraduates and to motivate alumni brothers of all socioeconomic levels to make a difference in their contributions."
